



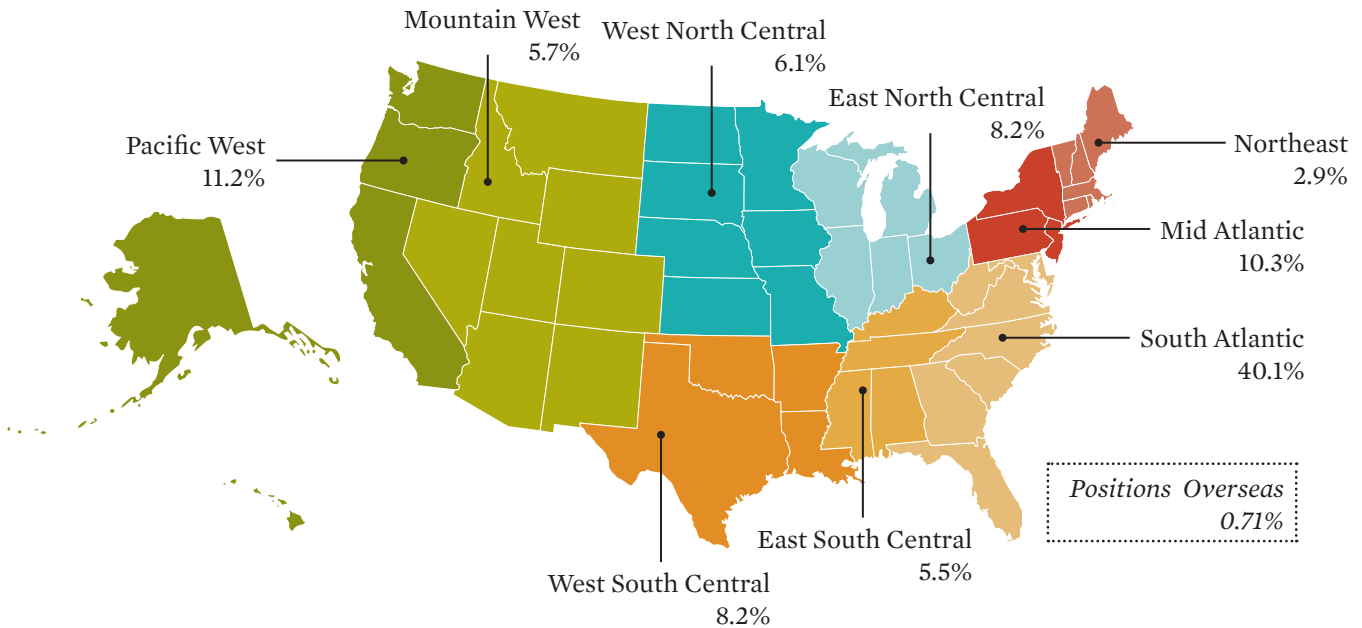

## FEDERAL CAREER GUIDE

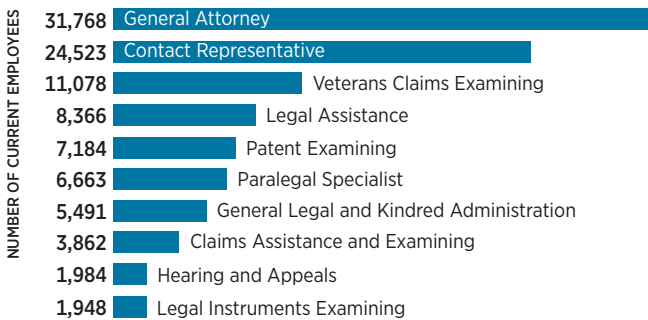

For example, legal assistants conduct legal research at the Department of Labor, patent examiners analyze and research new inventions for the Department of Commerce, and attorneys resolve complex law questions at the Millenium Challenge Corporation.

### Legal Positions by Region

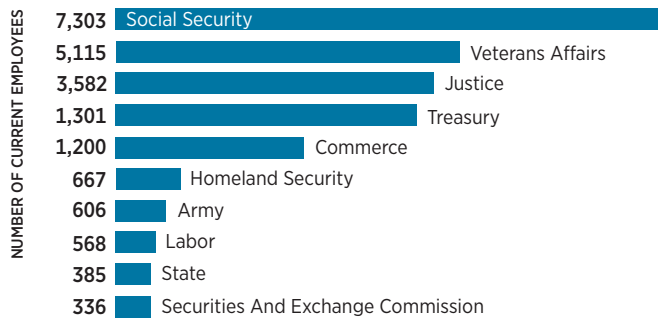


### Top Legal Fields

## SEARCH FOR LEGAL POSITIONS

With so many opportunities to use your legal skills, it may be helpful to sort positions by **job category**. The most common categories are listed below. You can search [USAJOBS.gov](https://www.usajobs.gov) using these keywords or by using the job series code, a four-digit number corresponding to a government job category.

### Did You Know?

- More than 80 percent of general attorneys in the federal government make at least \$100,000 per year.
- There are more than 200 federal employees currently working in legal positions overseas.
- Not all legal positions require a law degree or membership to the American Bar Association. For example, if you have a bachelor's degree or one year of specialized experience, you qualify for an entry-level job as a legal assistant, a contact representative, or a benefits specialist, just to name a few.

### Examples of Job Positions

#### Paralegal Specialist (0950)

Department: Department of Homeland Security  
Agency: Customs and Border Protection  
Salary Range: \$27,000-\$44,000/year  
*Location: New Orleans, Louisiana*

As a Paralegal Specialist, you will:

- Perform legal support work on cases related to seizures, penalties and liquidated damages
- Review and finalize claims
- Prepare synopses of cases
- Hold conferences with the public to provide status of cases or required procedures

#### Attorney Advisor (0905)

Department: Department of Justice  
Agency: Office of the Inspector General  
Salary Range: \$105,000-\$156,000/year  
*Location: Washington, D.C.*

As an Attorney Advisor, you will:

- Plan, organize and conduct investigations into sensitive allegations concerning government officials and programs
- Compile and analyze documents and testimony, interview witnesses and subjects, and prepare memoranda and reports
- Make recommendations for policy changes, administrative action or criminal prosecution
